Sealed Bids for **Project Number FC-6902 Taxiway Markings Replacement with Paint at Hartsfield-Jackson Atlanta International Airport (“Airport”)** will be received by designated staff of the Department of Procurement (“DOP”), at 55 Trinity Avenue, City Hall South, Suite 1900, Atlanta, Georgia 30303, on **Wednesday October 16, 2013**.

Bids will be publicly opened and read after 2:00 P.M., in Suite 1900, 1<sup>st</sup> Floor, City Hall South, and 55 Trinity Avenue, S.W., Atlanta, Georgia.

Scope of Services: The removal of 1,125,000 square feet existing taxiway centerline and edge markings, and application of new markings with paint to meet current FAA criteria.

Bidders must submit on the forms provided in the Bid document and shall be sealed in envelopes, clearly marked and labeled with the formal contract number FC-6902, the title of the project, full name and complete address of bidder and date and time Bids are due. All Bids must be hand delivered, mailed via United States Postal Services or delivered by courier service. No facsimile(s) will be accepted.

All forms required by the **NOTICE OF REQUIRED SUBMITTALS** must be included in the Bids. The Bids shall contain the full name of each person, firm or corporation and the complete address.

Pre-Bid Conference will be held on Wednesday, **October 30, 2013 at 2:00 P.M.**, at the City of Atlanta, Technical Support Campus, and 1255 South Loop Road, College Park, Georgia 30337. There will be representatives from the Department of Procurement, Office of Contract Compliance and the Department of Aviation available at the conference to discuss the project and to answer any questions.

This Invitation to Bid (“ITB”) is being made available by electronic means. If accepted by such means, then the Proponent acknowledges and accepts full responsibility to insure that no changes are made to the ITB. In the event of conflict between a version of the ITB in the Proponent’s possession and the version maintained by the DOP, the version maintained by the DOP shall govern.
