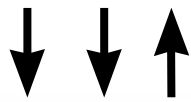

BETWEEN I-20 AND AND MEMORIAL DRIVE/PEACHTREE STREET: ERADICATION OF EXISTING PAVEMENT MARKINGS AND CONVERSION OF 3 LANE ROAD TO 2 TRAVEL LANES AND 2 BUFFERED/PROTECTED BIKE LANES WITH KEY TURN LANES AT INTERSECTIONS

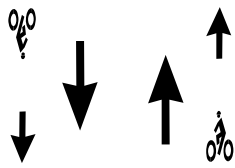

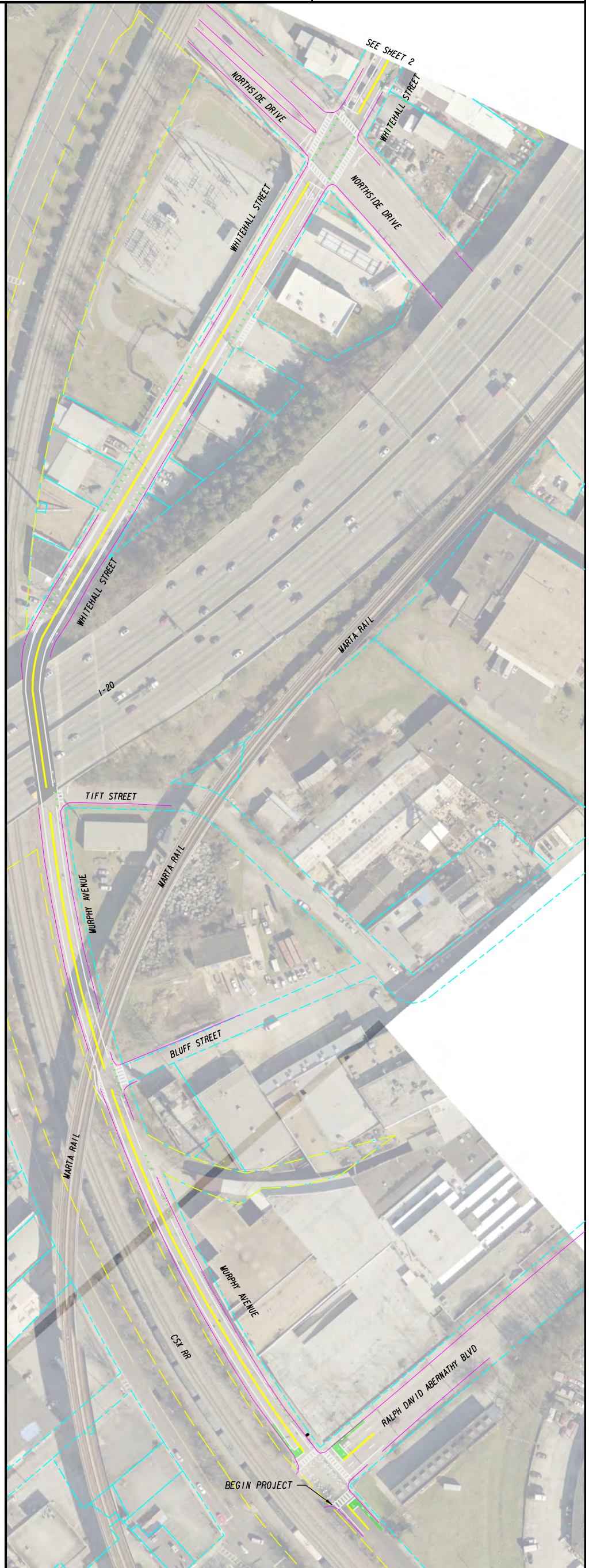

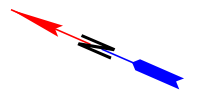

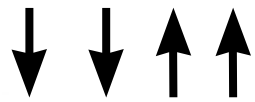

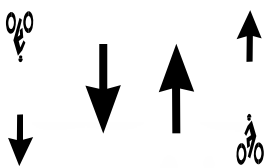

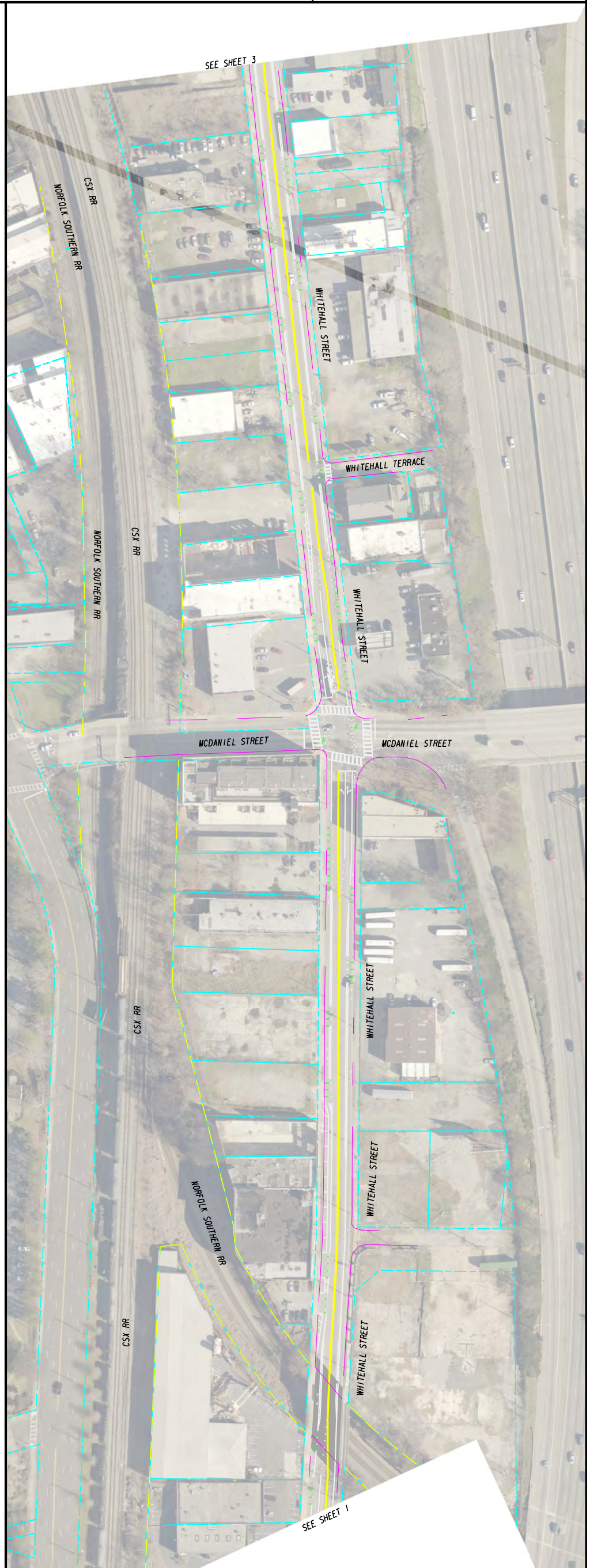

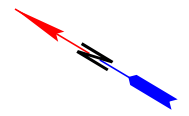

WHITEHALL STREET/MURPHY AVENUE CONCEPT LAYOUT MAP (3 OF 3)

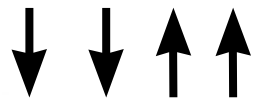

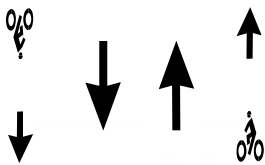

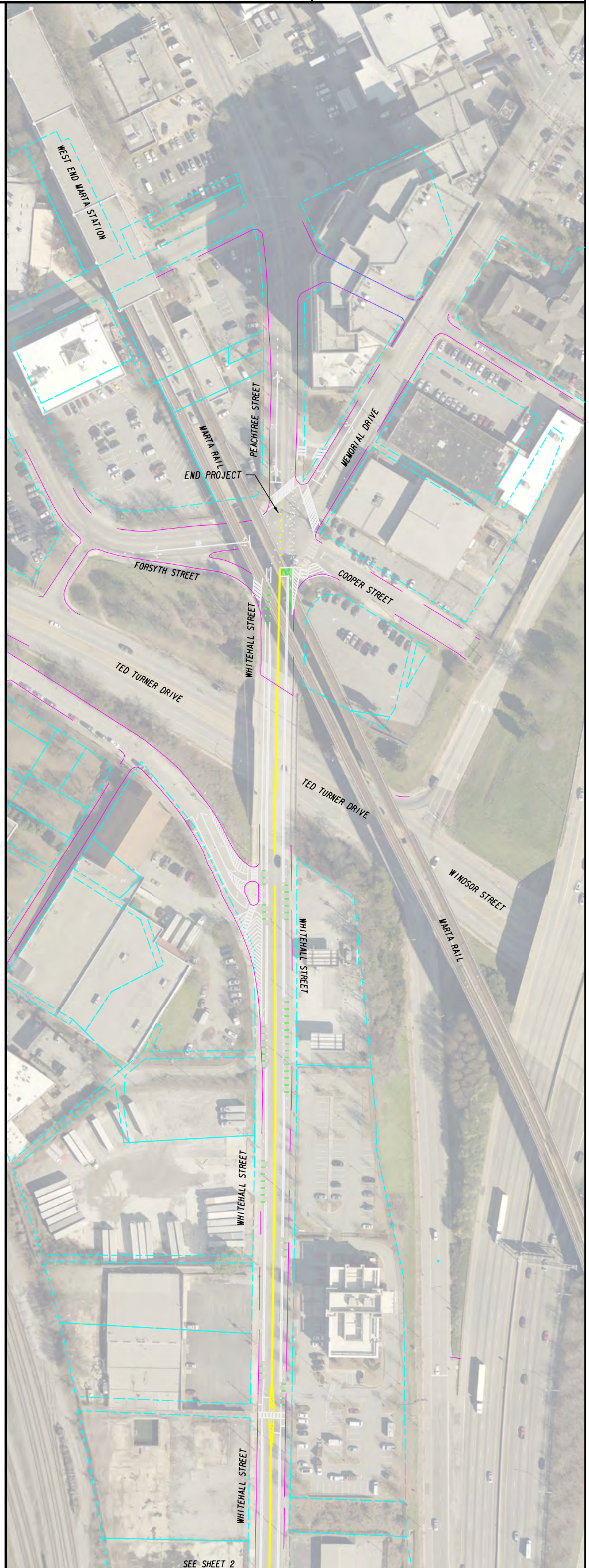
Whitehall St Existing
