A PERMIT IS REQUIRED FOR ALL AMPLIFIED SOUND.

Sound may be used inside a pavilion only with an appropriate permit. Sound may be not be plainly audible outside the distance of 100 ft. from the noise source (100 ft. radius around noise source is permitted and never plainly audible outside the perimeter of the park); Attendance of 500-750 people - 150 ft.; 750+ people - 200 ft. (Ordinance Section 110-75 and 110-76)

EVENT BOND: A \$100 Bond is required for all pavilion and greenspace reservations and may be withheld for violating terms of permit.

RESERVATIONS

Reservations cannot be made any earlier than 90 days prior to the event, or any later than 14 days before the event. DPR facility reservations can currently be made online. This includes reservations for ball fields, pavilions, greenspaces, and rooms within Community Centers. In order to complete a reservation, an online account is required. SPECIAL RULES FOR PARKS

No horses or ponies are allowed in any park at any time. (Except for law enforcement horses engaged in official duty and Chastain horse park) Ordinance Section 110-71

GRILLS

IN PIEDMONT PARK - Portable grills are prohibited. Stationary grills throughout the park are available for public use. *Ordinance Section 110-76 (a)(4)*

Portable grills are allowed in all other COA Parks, however; used charcoal must be deposited in City-provided receptacles that are clearly marked for charcoal disposal. *Ordinance Section 110-76 (a) (3)*

CITY OF ATLANTA **PARK RULES**



Parks open 6AM - 11PM



All pets must be on a leash, except in designated areas. *Ordinance Sec. 110-70*



No alcoholic beverages, except by special permit. *Ordinance Sec. 110-76*



No selling food, drinks, clothing, souvenirs or anything else, except by special permit. *Ordinance 110-62*



Glass containers forbidden. *Ordinance Sec. 110-59 (a) (13)*



No amplified music allowed, except by special permit. *Ordinance Sec. 110-76(2)*



Athletic fields, playgrounds, picnic tables, benches and other amenities must be used for their intended purpose. *Ordinance Sec. 110-59*



No tents with floors, and no tents larger than 10'x10' except by special permit. No laying of non-permeable ground covering, except as per *Ordinance Sec. 110-59*



No moonwalks, generators, or other equipment requiring electricity except by special permit. *Ordinance Sec. 110-59(8)*



Dispose of charcoal in designated containers. *Ordinance Sec. 110-59(16)*



Place all litter in receptacles. *Ordinance Sec. 130-6*



No vehicles shall drive upon or across any part of any public park, except on paved roads and parking lots. *Ordinance Sec. 110-86, 110-87*
